



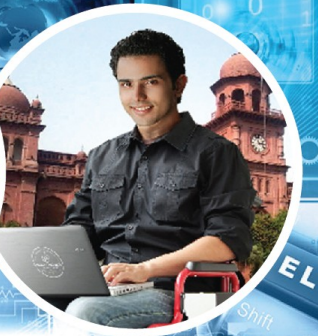

Prime Minister's Laptop Scheme (Phase-III)

Prime Minister's Laptop Scheme is a revolutionary initiative to enhance the scope of research and quality education in the country and increase the access of Information Technology. Students studying in Public Sector Universities/ Degree Awarding Institutions recognized by Higher Education Commission (HEC) are advised to get registered online on <http://pmnls.hec.gov.pk> and update their profiles.



Eligibility Criteria

- ▶ Must be enrolled in a Public Sector University/ College/ Government College of Technology as of June 30, 2016
- ▶ Students enrolled in PhD/ MS/ MPhil or equivalent of 18-year programme
- ▶ Students enrolled in one or two year Masters degree programme i.e. equivalent to 16-year education (morning and evening)/students enrolled in four-year or five-year Bachelors degree programme (morning and evening)
- ▶ Students studying as distant learner in Virtual University of Pakistan or Allama Iqbal Open University
- ▶ Students studying in government degree or postgraduate colleges of Federal Capital (ICT) and Federally Administered Tribal Areas (FATA).
- ▶ Students' eligibility and enrolment status as defined above shall be determined on the day of distribution of laptops, however if there is any unforeseen delay causing ineligibility of students, then those students having their online application submitted and "Accepted for Merit" will maintain their eligibility intact.

▶ Students enrolled after following dates shall be considered eligible:

5.	Undergraduate (4/5 Years)	June 30, 2012/ June 30, 2011
6.	Diploma of Associate Engineering	June 30, 2013
7.	FA/ FSc (Only for FATA and ICT regions)	June 30, 2014

▶ FATA – Federally Administered Tribal Area. ▶ ICT – Islamabad Capital Territory.

Distribution Criteria

- ▶ Full coverage to newly enrolled PhD, MPhil, MS 18 years or equivalent programme students in any public sector HEI
- ▶ 2.5% Quota (i.e. 2500) for distance learning students of Virtual University and 2.5% Quota (i.e. 2500) for Allama Iqbal Open University
- ▶ 5% Quota (i.e. 5,000) for students of Government Colleges of Technology
- ▶ 5% Quota (i.e. 5,000) for students of degree and postgraduate colleges of Islamabad and FATA
