NOTIFICATION

In pursuance of Universities & Boards Department, Government of Sindh vide Notification No. SO(Admin)/U&B/NCOC/4-39/2020 dated 25-11-2020, the NED University of Engineering and Technology and its Constituent College i.e Thar Institute of Engineering, Sciences and Technology, Tharparkar will observe the following with immediate effect to 08-01-2021:

- 1. Staff engaged in teaching and non-teaching departments will be called at the discretion of Chairperson/HOD's on rotation basis.
- 2. Staff of the NOC, Security, Drivers (LTV), Sports, Medical Department and Essential Services shall perform their duties as usual.
- 3. All canteens (except Environmental Canteen) shall remain closed and point/shuttle services are suspended.
- 4. All students will not be allowed to enter the University during this period.
- 5. Furthermore, the students engaged in research/lab work and thesis at PhD level will continue their activities as per routine with strict follow-up of SoP's.
- 6. One third (1/3) of the students (foreigner and those belong to remote areas, where there is hardly any internet facility) would be allowed to the hostels under strict SoPs.
- 7. No overtime shall be allowed to any department (Except Essential Services i.e. NOC, Security, Drivers (LTV), Medical & Essential Services).
- 8. All employees are strictly advised not to leave the Headquarters' without permission and also to keep their cell phones ON with their presence ensured through Whatsapp and email in order to have further coordination and correspondence in the wake of COVID-19 Pandemic.

It is further hereby notified that the NED University of Engineering & Technology and its Constituent College i.e Thar Institute of Engineering, Sciences & Technology, Tharparkar shall observe the **following office hours with immediate effect to 08-01-2021**:

Monday to Thursday Friday 9:00 hrs. to 14:00 hrs. 9:00 hrs. to 12:00 hrs.

At the wake of recent outbreak of second wave of COVID-19, the precautionary measures need to be strictly followed, as per the instructions of Government of Sindh.

ALL EMPLOYEES /STUDENTS /CONTRACTORS MUST FOLLOW THE FOLLOWING SOP:
